Overview

North Muskegon Schools is seeking bids for the installation of Safety Security Film for the entire 1st floor of our building. This work includes the installation of security film and attachments if applicable. Installation of these items will be scheduled upon contract award.

Bids are to be submitted via mail to North Muskegon Schools, Attn: Director of Technology, 1600 Mills Ave., North Muskegon, MI 49445 by 1:00 p.m. Eastern Time, June 12th, 2023. No bids will be accepted after 1:00 p.m. Eastern Time, June 12th, 2023.

All bids, received prior to 1:00 p.m. Eastern Time, will be publicly opened and read aloud at that time. Bids received after the stated time will be returned to the bidder unopened.

Contractor Requirements

Manufacturer Qualifications: All products installed will be supplied by a single manufacturer.

Installer Qualifications: Installer is an authorized 3M product installer and has a minimum of five years demonstrated experience in installing products of the same type and scope as specified.

Provide a reference list of 5 commercial buildings where the contractor has installed safety window film in the last year.

Contractor to provide submittals of all products and samples as requested.



Installation requirements

Install all products according to manufacturer's instructions.

Store products per manufacturer's instructions in original packaging until ready for installation.

Products are to be installed in environmental conditions that meet the requirements of the Manufacture.

Film is to be installed uniformly with no noticeable pin holes, streaks, thin spots, scratches, banding, or other visible defects.

Properly clean surfaces prior to installation and prepare all surfaces in accordance with the manufacturer's instructions.

Product Requirements

Base Bid Product shall be 3M Safety and Security Window Film Ultra Series (Ultra 800) optically clear.

Installed with 3M Impact Film Attachment System.

Bid Requirements

Complete the following documents that are included in this document. Please provide three copies of all 4 of the required documents.

The following is the estimated quantities of products that should be used for bidding purposes: **86,000 Square Feet**

Contractor is responsible to confirm with the owner actual total installation quantities prior to the award of work. Change to estimated square foot of safety film or and running feet of attachment system will be added or subtracted to the award bid based on the cost per square foot on the bid proposal sheet.

Desired Installation Time-Line
